Re: Further Advice on Your Immigration Situation

I do hope that this letter finds you okay. We shared our common opinions after the consultation I had conducted. After carefully paying close attention to the case, I would like to offer you all the answers that you need to know during our meeting.

Staying with Viet Nguyen after Prison Release: When the sentence you had just served is over, choosing to remain with Viet Nguyen is the next logical step. On the one hand, it is a very specific transition process whereas on the other hand, there is a certain order of steps in it. Hence, seek knowledge on the fact that Mr. Viet Nguyen doesn't have Indefinite Leave to Remain but limited leave to remain, it is indispensable to consider what your immigration status is and if it complies with staying with him. I will give more details about this issue and offer guidance on how every person can address this.

Moving to Stay with Binh Be: You told me you longed to be somewhere where it was prettier and livable, somewhere like Be Binh. Granted, this might be the case, however, you should not forget to make sure such change remains in concerted tune with your immigration status and requirements. I will render timely help to you so you can successfully navigate this process to comply with the relevant rules and regulations

Financial Support and Employment: Considering sufficient means of survival, especially after being released from crime behind hours, is one of the vital tasks. For those who are facing immigration and may be processing their cases through the Salvation Army, some organizations can support you, such as the Salvation Army. While studying, it is important as well to look for

employment options since it is a huge factor for financial security. I will explain the work eligibility for you as well as give relevant information about the limitations of your work.

Salvation Army Assistance: The history of The Salvation Army has been paved by their financial assistance to individuals who are like you, facing tough times. I will ensure that we jointly contact them and investigate their potential to fund us. The moving process might appear overwhelming, but we will guide you through each step of the way to provide the support you require.

In this regard, following your relocation to an Immigration Removal Centre, keeping in touch with the facility services as well as engaging legal representation is of utmost importance. Should know that I will ensure to keep you represented on legal aid contracts subject to certain underlying conditions. I will take into account the conditions of your detention in order to illustrate that you are always safeguarded within the asylum procedures.

I am fully aware of the fact that this is a difficult period for you but you can be relaxed because I am always ready to fight and stand firm for your rights at any time. If please feel free to get back to me whenever you have a doubt and remain assured of my support.

QUESTION 12

Answer: If Viet Nguyen does not hold Indefinite Leave to Remain and was charged for driving without insurance, this infraction may well cause the restricted option of staying with him after his discharge. Therefore, considering the restrictions of his immigration status and his prior record, the adequacy of staying at this accommodations center must be subject to reconsideration. On the contrary, it can also create some reservations about what pregnancy problems or the risk of those who are illegal can arise in the living conditions of somebody who has no consistent immigration status. Taking into account this new information, I believe it would be best to look the alternative shelter options and get advice on how to move forward.

QUESTION 13

Answer:

CIRCUMSTANCES:

- This is generally related to the contract you have signed for legal aid services in the immigration aspect, which includes asylum applications and other specific immigration issues.

- Meanwhile, Khuyen fulfills the conditions for given legal justice by providing the means and merits that are consistent.
- Knowing that Khuyen would permit you to act on his behalf and no interest conflicts that would hinder representation, the situation is green-lit.
- Now, you can serve him using reliance on phone calls and law assistance, as he is already being held in detention.

In this manner, Khuyen will have a valid asylum process in conditions of due process where you'll carry on his representation until his case is decided on and his rights assured.
